- A meeting with lighting company, Innovative Outdoor Lighting, took place regarding lighting the bridge
  - They came and looked at the bridge
  - LED lighting would have a minimal cost
  - Up lighting would be best
  - Maybe ½ moon lights on the railings
  - Demonstration can be scheduled
  - Ballpark costs \$ 6000
  - They will spot for events in exchange for advertising

- Plug not an option because City wants it metered separately
- Economic Restructuring Committee Update (given by SH)
  - Met at regular time
  - Drawings for new downtown development project were reviewed
  - Talked about lighting water tower and adding a logo
    - Cost prohibitive
    - o Approximately \$7500 to put a logo on it
    - o Approximately \$3000 just to put writing on it Historic Senoia
    - o Need to get another competitive bid
  - Trolley discussion occurred
    - o There is no place to store it downtown needs to be covered
    - Need a meter to fill with gas
    - o Need a driver with CDL
    - o Is it possible to turn it into a Welcome Center?
  - A charging station for cars and golf carts was discussed

    - o 4 people in attendance
    - Need volunteers to run events
    - o Started talking about Memorial Day, May 25
    - Tour of Homes
      - Need to better identify houses
      - Bigger map
